Construction Approval Pending— Let's Hope! Let's Hope!!!

If approved by the Fairfax County Park Authority (FCPA) Board at its April meeting, construction at Huntley actually may start this coming October! What good news that is! There are many to thank for moving this forward—folks at headquarters and staff at Huntley Meadows Park, but especially Congressman Jim Moran! Congressman Moran included \$100,000 for Huntley construction in the FY 2009 Omnibus Appropriations Act. The Huntley funds will be administered by the National Park Service through the Save America's Treasures program. That funding plus the funds in the 2008 bond issue allocated to Huntley surely will put us over the top and make construction possible.

The exterior restoration of the main house will remove non-period additions on the north and west sides of the structure and reconstruct the exterior to appear as it did in the early 19th century. The exteriors of the outbuildings will be restored to the same period. The interior of the house will be renovated to provide public access for cultural programming including learning lab spaces and a public restroom in the basement level and exhibit rooms on the main level. The cost estimate for preparing the bid documents and completing the recommended scope of work is \$2,500,000.

If the FCPA approves the scope as presented, construction would start around October 2009 and be completed by June 2011. •

Nonstate Agency Grant

FCPA staff is investigating a variety of ways to spend the Nonstate Agency Grant funds by the June 30 deadline. This is a \$23,750 earmark from the 2007 state budget bill administered by the Virginia Department of Humanities.

The funds will be used for all or some of the following projects: restoration of the historic landscape, sign design and fabrication, and an electric cart required by the Americans with Disabilities Act.

The restoration of the historic landscape will follow the recommendations in the *Cultural Landscape Report* prepared by John Milner Associates for the FCPA. The view from the house will be enhanced by removal of selected trees. After restoration of the house is complete, period-appropriate and native plantings will be installed. The woods buffer between the site and the surrounding neighborhood will be retained, but there will be removal of invasive species. ��

Budget Concerns

The FCPA will vote on the final budget for FY2010 on April 27. As we are sure you are aware, reduced tax revenue has necessitated drastic cuts in the county budget. The parks were especially targeted for staff and funding cuts. Plans call for cutting some staff positions while others will be only funded at 50 percent, with parks required to raise the remaining amount to keep the positions. Seasonal staff would be cut 50 percent. Historic Huntley will not be directly affected, but cuts to Huntley Meadows Park (HMP) will indirectly affect Huntley. Friends of Huntley Meadows Park have been active in an effort to inform HMP users through flyers and by speaking in support of the park at public forums. The parks are a valuable resource that enhances our quality of life. Please give your support to Huntley Meadows Park. �
