Restoration News

The invitation for bid for restoration of Historic Huntley (officially entitled Huntley Historic Site—Rehabilitation of the Main Building and Restoration of the Historic Out Buildings) was advertised in February 2010. Thirteen bids were received on the bid opening date, March 3, 2010. Bids ranged from \$1,145,000 to \$2,100,000 and currently are being evaluated. Restoration is anticipated to commence this summer. Contractors have been contacted to provide a cost proposal for professional services to assist with review and inspection of historic materials during the construction phase. •

Section 106 Process

As part of the rehabilitation and restoration process, Friends of Historic Huntley has been invited by the National Park Service, along wth a distinguished list of other organizations, to participate in the Section 106 process regarding the Save America's Treasures Grant for Historic Huntley. Consultation is ongoing with the Fairfax County Park Authority and the Virginia State Historic Preservation Office to develop a programmatic agreement on the property. Section 106 of the National Historic Preservation Act of 1966 requires federal agencies to take into account the effects of their undertakings on historic properties. The historic preservation review process mandated by Section 106 is outlined in regulations issued by the Advisory Council on Historic Preservation. •

Fairfax County 2011 Budget

Help is needed to protect Fairfax County parks from 2011 Fairfax County budget cuts. To meet the deep budget deficits in part, proposed cuts include up to 15 percent to the Fairfax County Park Authority. This will have a severe effect on the county's stewardship and preservation of natural and cultural resources. The construction work at Huntley is grant funded so that is not affected. The budget that the county executive proposed largely spares Huntley Meadows Park (HMP), but that could change. Park maintenance support will be greatly impacted by the proposed budget. What can you do? Contact members of the Fairfax County Board of Supervisors. Send an email, make a phone call, or write a letter—let your voice be heard. Tell them you value the parks and museums within the parks for your enjoyment and to teach your children about the history of Fairfax County and the natural world. Internship Opportunity at Huntley

Friends of Historic Huntley have made funds available for a history/preservation internship at Huntley Meadows Park to study Historic Huntley. The intern will photograph the historic house to record existing conditions before construction begins and match findings with the Historic Structures Report and other studies of the house. They will also inventory and record architectural artifacts now in storage; conduct oral histories; perform library research; and assist with the development of interpretative signage for the site. The intern will work 40 hours a week for 11 weeks beginning around May 31, 2010, and receive a stipend of \$2,700.
